**RE:** Statement of Interest for Core Program – 2020 Recommendations for

Invitations to Eligibility Period

The Massachusetts School Building Authority (the "MSBA") opened the 2020 Statement of Interest (the "SOI") filing period on January 8, 2020. The filing deadline for the Core Program was May 6, 2020, with 71 SOIs submitted for consideration. Of the 71 SOIs submitted, 41 were designated as the priority school. Beginning in May 2020, the MSBA conducted its due diligence on the SOIs that were submitted for the Core Program, as outlined in **Attachment A**, "SOI Process Overview for Core Program", and as noted below:

- Review SOI submissions for completeness votes, signatures and supporting documentation;
- Review SOI submissions and accompanying documents for content; and,
- Conduct senior study visits, if necessary.

Due to ongoing public health issues, the MSBA's due diligence for the 2020 Core Program, which includes senior study visits to select schools was delayed. Unlike prior years in which project invitations were approved at the December Board meeting, staff completed virtual senior study meetings and site visits in January and February 2021 after reviewing and discussing further review recommendations at the December 2, 2020 Facilities Assessment Subcommittee meeting.

As discussed with the Board during the 2020 SOI process and most recently at the March 24, 2021 Facilities Assessment Subcommittee meeting, the MSBA has now concluded its due diligence for the 2020 SOIs. MSBA staff is recommending that the Board vote to invite the 15 Districts and schools listed below and found in **Attachment B** into the Eligibility Period.

Upon approval by the Board, each District and school is invited into the 270-day Eligibility Period with a specified effective date for commencement, and any approval of a potential grant for the scope of work as identified herein will not be made before July 1, 2023. As part of its due diligence, MSBA staff has discussed the Eligibility Period requirements and the specific funding timelines with Districts. The Districts are aware of the effective dates for commencement of Eligibility Period as found below and the dates for potential grant approval.

<sup>&</sup>lt;sup>1</sup>The filing deadline for the Accelerated Repair Program (the "ARP") was February 14, 2020 with 90 SOIs submitted. Invitations into the ARP concluded at the December 16, 2020 Board of Directors meeting and 18 districts, representing 25 projects, were invited into the ARP.
