## Recommendation

That the Executive Director be authorized to enter into a Project Scope and Budget Agreement and a Project Funding Agreement with the City of Lynn (the "District") to replace the existing Pickering Middle School with a new facility serving grades 6-8 on the site of the existing Pickering Middle School, Sisson Elementary School, and adjacent Magnolia Park.

The District's proposed project site is partially located on the adjacent Magnolia Park, which is subject to the protections of Article 97 of the Amendments to the Massachusetts Constitution. Therefore, the MSBA Board's authorization to enter a Project Scope and Budget Agreement and a Project Funding Agreement, will be conditioned upon the District meeting the MSBA requirements for ownership, control, and use of the proposed project site.

Additionally, the District's proposed project is subject to the review of the Massachusetts Environmental Policy Act Office ("MEPA Review"). Therefore, the MSBA Board's authorization to enter a Project Scope and Budget Agreement and a Project Funding Agreement will be conditioned upon the District fulfilling the applicable MEPA requirements associated with the MEPA Review.

## **Discussion**

MSBA staff reviewed the documents provided by the District and met with the District and its consultants to discuss the project's scope and budget. The District has provided a Total Project Budget of \$168,268,362, which includes an estimated construction cost of \$133,993,738 (\$732/sq. ft.). The Estimated Basis of Total Facilities Grant would be \$128,655,098, which excludes feasibility study and schematic design costs as a result of previous state funding associated with MSBA's participation in the District's 2015-17 Feasibility Study, OPM and Designer fees beyond MSBA's funding limits, costs associated with other administrative costs, costs associated with work at the adjacent Sisson Elementary School, construction costs beyond MSBA funding limits plus eligible demolition and abatement, costs associated with mailing and moving, costs in excess of \$1,200 per student allowance for furniture, fixtures, and equipment, costs in excess of \$1,200 per student allowance for technology, costs associated with the commissioning of ineligible building area, and owner's and construction contingency costs.

MSBA staff recommends an Estimated Maximum Total Facilities Grant of \$102,922,982; however, the District may be eligible for up to an additional \$1,607,925 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a Maximum Total Facilities Grant of \$104,530,907 for the Project Scope and Budget Agreement and Project Funding Agreement for to replace the existing Pickering
