Discussion

The OPM and Designer conducted a feasibility analysis of the facility and developed a schematic design including a proposed scope of work, schedule, and estimated budget. The District's Designer, Civitects, recommends a roof and window/door replacement. The Designer has confirmed that the roof will be in compliance with the MSBA's sustainability requirements.

MSBA staff reviewed the consultants' existing conditions analysis and proposed schedule provided by the District and have discussed the scope and budget with the District and its

consultants. The District has provided a Total Project Budget of \$2,318,019 which includes a construction cost of \$1,798,916. Construction costs include:

- \$14.80/sf for the PVC roof
- \$505,710 for associated roof work
- \$115.98/sf for windows and demolition
- \$232.640 for abatement and associated window work

The District is also proposing one deduct alternate which is not included in the Total Project Budget:

- \$47,029 to replace the roof with EPDM in lieu of PVC.

MSBA staff recommends an estimated maximum Total Facilities Grant of \$1,091,870; however, the District may be eligible for up to an additional \$49,751 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a maximum Total Facilities Grant of \$1,141,621 for the Project Funding Agreement for a roof and window/door replacement project at the Smith Academy.

² Scope exclusions /ineligible costs include consultant costs in excess of the 20% soft cost cap as well as legal fees.

³ Does not include any grant funds for potentially eligible owner's or construction contingency expenditures; subject to MSBA review and audit.

⁴ Includes maximum possible owner's and construction contingency grant funds, the final amount of which, if any, shall be determined by the MSBA in its sole discretion. The MSBA does not anticipate that the District will expend all of its contingency funds on expenses that are eligible for MSBA reimbursement.
