  - 50 facilities have been invited into the Program
  - 19 SOIs have been returned to core review
  - 10 facilities received "No action Letters"



#### 2013 SOI Review Process

- SOI Review for Core Program
- 141 SOIs submitted by 83 districts:
  - 37 New Construction
  - 46 Repair
  - 58 Addition Renovation
  - Content review of the SOIs began in the Summer of 2013


# Construction Estimate vs. 2013 Bid Amount

- All 2013 bids have come in.
- Core Program
  - 18 bids received and 12 GMPs executed in 2013.
  - Of the 30 projects, 23 bids came in within the estimated budget.
- Science Lab Initiative
  - Of the eight projects; eight bids have been received.
  - All eight are within the district's estimated budget.
- Accelerated Repair Program
  - Out of 36 projects, 31 bids were received 2013.
  - Of the 31, 29 bids have been reported.
  - Of the 29 projects, 25 bids came within the estimated budget.




## Eligibility Period / Educational Profile

- The MSBA recommends the introduction of an Educational Profile during the Eligibility Period to be completed by districts receiving an invitation to Eligibility Period as of January 1, 2014.
- Over the next two years, MSBA staff will monitor the information received from the Educational Profiles and seek input from districts regarding the information requested.
- MSBA staff will assess the impact of the Educational Profile questionnaire submitted by districts at the end of the Feasibility Study phase as a means to inform future efforts.

# Feasibility Study Duration Recommendations

- Establish a 30-month term duration for Feasibility Study Agreements
- Allow a one-time extension of up to six months (maximum of 36 months total), at the discretion of the MSBA's Executive Director. Additional extensions would require Board Authorization.
- Make effective for District's receiving an invitation to collaborate with the MSBA to conduct a Feasibility Study as of January 1, 2014.






