If the District does not meet the requirements for the energy efficiency, the District will not qualify for these incentive points, and the MSBA will adjust the reimbursement rate accordingly.

Discussion

MSBA staff reviewed the documents provided by the District and met with the District and its consultants to discuss scope and budget. The District has provided a Total Project Budget of \$111,587,059, which includes an estimated construction cost of \$91,217,674 (\$719/sq. ft.). The Estimated Basis of Total Facilities Grant would be \$60,378,062, which excludes a portion of the feasibility study amount as a result of previous state funding associated with the District's 2008 feasibility study, scope excluded OPM and Designer fees associated with the auditorium, costs associated with ineligible square footage, OPM and Designer fees in excess of MSBA funding limits, costs associated with permitting, costs associated with abatement of asbestos-containing floor materials, site costs in excess of 8% of total building cost, construction costs in excess of \$360/sq. ft. plus eligible demolition and abatement, costs associated with mailing and moving, costs in excess of the \$1,200 per student allowance for fixtures, furniture, and equipment, costs in excess of the \$1,200 per student allowance for technology, cost associated with the commissioning of ineligible square footage, and cost associated with owner's and construction contingency.

MSBA staff recommends an Estimated Maximum Total Facilities Grant of \$44,790,070; however, the District may be eligible for up to an additional \$2,030,232 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a Maximum Total Facilities Grant of \$46,820,302 for the Project Scope and Budget Agreement and Project Funding Agreement for an addition/renovation project at the existing David Prouty High School that will continue to serve students in grades 9-12 and will incorporate district-wide Pre-kindergarten.

²Does not include any grant funds for potentially eligible Owner's or Construction Contingency Expenditures; subject to MSBA review and audit.

³Includes maximum possible Owner's and Construction Contingency grant funds, the final amount of which, if any, shall be determined by the MSBA in its sole discretion. The MSBA does not anticipate that the District will expend all of its contingency funds on expenses that are eligible for MSBA reimbursement.
