Discussion

The OPM and Designer conducted a feasibility analysis of the facilities and developed Schematic Designs including proposed scopes of work, schedules, and estimated budgets. The District's Designer, Tighe & Bond Designer Services, Inc., recommends roof replacement at the Herbert Clark Hoover Elementary School and roof replacement at the Horace Mann Elementary School. The Designer has confirmed that the roof replacement at Herbert Clark Hoover Elementary School and roof replacement at the Horace Mann Elementary School and roof replacement at the Horace Mann Elementary School will be in compliance with the MSBA's sustainability requirements.

MSBA staff reviewed the consultants' existing conditions analyses and proposed schedules that were provided by the District. Also, MSBA staff discussed the scopes and budgets with the District and its consultants.

At the Herbert Clark Hoover Elementary School, the District has provided a Total Project Budget of \$2,306,449, which includes a construction cost of \$1,881,016. Construction costs include:

- \$747,567 (\$42.20/sf) for the installation of 90 mil ethylene propylene diene monomer ("EPDM") roof;
 \$127,577 of which is ineligible for exceeding the \$35/sf roofing cost cap;
- \$479,556 for demolition as well as protection of existing-to-remain roofs and windows;
- \$220,978 for metal decking repairs;
- \$62,831 for Masonry, roof blocking and rough carpentry;
- \$172,670 for access hatch, walkway pads, accessories and sealants, flashing and trim;
- \$45,979 for plumbing;
- \$89,364 for HVAC removal and installation;
- \$62,071 for electrical

At the Horace Mann Elementary School, the District has provided a Total Project Budget of \$1,460,177, which includes a construction cost of \$1,113,143. Construction costs include:

- \$567,619 (\$42.20/sf) for the installation of 90 mil ethylene propylene diene monomer ("EPDM") roof;
- \$96,869 of which is ineligible for exceeding the \$35/sf roofing cost cap;
- \$298,611 for demolition as well as protection of existing-to-remain roofs and windows;
- \$7,568 for metal decking repairs;
- \$23,431 for roof blocking and rough carpentry;
- \$101,898 for access hatch, walkway pads, accessories and sealants, flashing and trim;
- \$42,011 for plumbing;
- \$35,486 for HVAC removal and installation;
- \$36,519 for electrical

MSBA staff recommends the Estimated Total Facilities Grants and the Maximum Total Facilities Grants set forth in the table below subject to MSBA approval and audit:
