Discussion

MSBA staff reviewed the documents provided by the District and met with the District and its consultants to discuss scope and budget. The District has provided a Total Project Budget of \$125,000,000, which includes an estimated construction cost of \$98,264,388 (\$664/sq. ft.). The Estimated Basis of Total Facilities Grant is \$112,591,133, which excludes the following: legal fees; OPM and Designer fees beyond MSBA funding limits; costs associated with permitting; costs associated with ineligible administrative costs; costs associated with recording fees; costs associated with special construction; costs associated with asbestos-containing floor material and ceiling tile abatement; costs associated with the removal of a fuel storage tank; construction costs for building work associated with ineligible building area; construction costs for site work beyond MSBA funding limits, which includes scope associated with ineligible building area; costs associated with mailing and moving; costs exceeding the \$1,200 per student allowance for furniture, fixtures, and equipment; and costs exceeding the \$1,200 per student allowance for technology. The Total Project Budget also excludes costs associated with the commissioning of ineligible building area, as well as the owner's and construction contingencies.

MSBA staff recommends an Estimated Maximum Total Facilities Grant of \$66,515,343; however, the District may be eligible for up to an additional \$1,741,638 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a Maximum Total Facilities Grant of \$68,256,981 for the Project Scope and Budget Agreement and Project Funding Agreement for an addition and renovation project at the Millis Middle/High School serving grades 6-12.

²Does not include any grant funds for potentially eligible Owner's or Construction Contingency Expenditures; subject to MSBA review and audit.

³Includes maximum possible Owner's and Construction Contingency grant funds, the final amount of which, if any, shall be determined by the MSBA in its sole discretion. The MSBA does not anticipate that the District will expend all of its contingency funds on expenses that are eligible for MSBA reimbursement.

⁴Maximum Total Facilities Grant will be allocated in part to the current Grant Cap, and in part to future available Grant Cap space.
